Vice President, Regional Market Manager, of California Bank & Trust. Grimes noted that the investment accounts were doing well. He also stated he was unaware of a revised investment policy adopted October 9, 2014 and that stock rating requirements changed from A to AA. Grimes recommended to rescind the new policy, as a rating of A is a tight portfolio and going to a rating of AA or higher will reduce the amount of stock availability.
