

RESOLUTION NO. 127

**RESOLUTION OF THE BOARD OF DIRECTORS
OF CRESTLINE SANITATION DISTRICT
AMENDING AND SUPPLEMENTING RESOLUTION NO. 126 AND
CONFIRMING THE REPORT OF DELINQUENT SEWER USER CHARGES
AND PROVIDING FOR COLLECTION ON THE 2026-27 TAX ROLL
AND AUTHORIZING THE ESTABLISHMENT AND
CONTINUATION OF COLLECTION OF
SEWER STANDBY AND AVAILABILITY CHARGES FOR FY 2026-27**

SECTION 1. The Board of Directors of the Crestline Sanitation District (“Board”) hereby finds and determines:

(a) That the report on sewer user charges for Crestline Sanitation District (“District”), as fixed by District Ordinance, the payment of which is shown to be delinquent in said report filed with the Secretary of the Board, is hereby confirmed for each property within District as set forth in said report.

(b) That the report on annual sewer and availability charges for the District, as fixed by District Ordinance and levied pursuant to Health and Safety Code Section 5471, is hereby authorized for continuation of collection on each property within the District as set forth in said report.

(c) That a public hearing on said reports was held on June 11, 2026, and that any protests or objections regarding the appropriateness of the charges or their collection on the tax roll were heard and considered, and thereafter Board duly adopted Resolution No. 126 authorizing the levying of annual sewer and availability charges on the 2026-2027 San Bernardino County Tax Roll.

(d) On or about August 10, 2026, the County of San Bernardino notified the District of new administrative requirements necessary to accomplish the levying of annual sewer and availability charges on the 2026-2027 San Bernardino County Tax Roll.

(e) The purpose of this Resolution is to supplement Resolution No. 126 adopted by the Board on June 11, 2026, to formally incorporate the new administrative requirements imposed by the County to levy annual sewer and availability charges on the 2026-2027 San Bernardino County Tax Roll.

SECTION 2. The Board hereby resolves and orders:

(a) That the Recording Secretary of the Board is hereby directed to certify to the passage of this resolution and to forward a copy of same to the following public body and officers: The Auditor-Controller/Recorder/Treasurer/Tax Collector of the County of San Bernardino.

(b) That the District’s Clerk is hereby further directed to forward a certified copy of said reports to the Auditor-Controller/Recorder/ Treasurer/Tax Collector of the County of San Bernardino.

(c) That the Auditor-Controller/Recorder/Treasurer/Tax Collector of the County of San Bernardino is directed to record such certified copy of said reports upon such properties as set forth in said reports.

(d) That the charges, fees, and/or assessments set forth in said reports, as hereby confirmed and authorized, shall be collected on the tax roll in the same manner and at the same time as general County of San Bernardino ad valorem property taxes are collected for fiscal year 2026-27 in the District.

(e) The Board hereby authorizes the District's General Manager to take any and all actions necessary to carry out the intent of the Board as set forth herein, and to cause the annual sewer and availability charges levied herein to be collected at the same time, and in the same manner, as the levying of special assessments on the 2026-2027 San Bernardino County Tax Roll, and/or to be otherwise collected in accordance with all legally-permissible methods available under applicable law.

(f) The Board hereby also authorizes and directs the San Bernardino County Auditor-Controller/Treasurer/Tax Collector to place the annual sewer and availability charges levied herein on the 2026-2027 San Bernardino County Tax Roll to be collected at the same time, and in the same manner, as the levying of special assessments thereon and/or to be otherwise collected in accordance with all legally-permissible methods available under applicable law.

(g) The Board hereby further authorizes the total amount of the charges, including any applicable County administrative or processing fees, to be placed on the San Bernardino County Auditor-Controller/Treasurer/Tax Collector annual tax roll and collected in the same manner as property taxes.

(h) If any annual sewer and availability charges hereby levied becomes delinquent, the amount of the delinquency, together with any interest and penalties thereon, shall constitute a lien on the affected property to the fullest extent legally allowable under applicable law.

(i) The purpose of this Resolution is to supplement Resolution No. 126 adopted by the Board on June 11, 2026.
