ORDINANCE NO. CSD 11-1

AN ORDINANCE OF THE BOARD OF DIRECTORS OF CRESLINE SANITATION DISTRICT ESTABLISHING SEWER USER CHARGES AND STANDBY CHARGES AND OTHER VARIOUS FEES

The Board of Directors of the Crestline Sanitation District, County of San Bernardino, State of California, ordains as follows:

SECTION 1. From and after the effective date of this ordinance, it shall be in full force and effect within the Crestline Sanitation District.

SECTION 2. Ordinance No. SD 10-08 is hereby repealed upon the effective date of this ordinance.

SECTION 3. There are hereby levied, pursuant to Health and Safety Code Section 5471, sewer standby and user charges as follows:

Monthly Sewer  
User Charges

\$35.95

Annual Sewer Availability  
Charges

\$10.00 per full acre, plus \$10.00 for any portion of a parcel which may exceed an exact number of acres. Parcels of less than one acre shall be charged \$10.00.

SECTION 4. There are hereby levied other fees and charges for services provided by Crestline Sanitation District as set forth in Exhibit 1, incorporated herein by reference.

SECTION 5. That such charges are not in excess of the cost of providing services, are required to fund the provision of such services, and reflect the costs of providing such services.

SECTION 6. The specified fees and charges are hereby established and shall be collected, unless delinquent, by Crestline Sanitation District through billing submitted to the owners of each parcel subject to the fees and charges.

**SEWER USER CHARGE**

The owner of each house, building or property connected to the public sewer shall pay a user charge based upon assigned Equivalent Dwelling Units (EDU). The EDU for each property shall be established in accordance with the State of California Uniform Plumbing Code, Table 7.


SECTION 8. This ordinance shall be effective thirty (30) days from date of adoption.
